Staged in Merimbula over the three days of the June long weekend, celebrations include cold water swims, trail running/walking and a street party done in the way only Merimbula knows how!

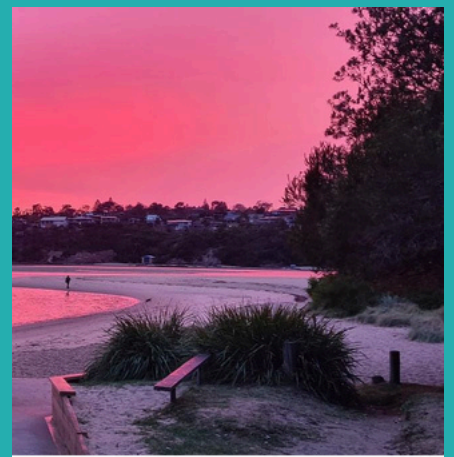
